Hollis To Run

Martha Hollis of Mimosa Drive has announced her candidacy for the Decatur City Commission seat presently occupied by Steve Johnson. A 22 year resident of Mimosa Drive, Mrs. Hollis was instrumental in the founding of WPNA and serves on the Executive Committee.

Mrs. Hollis, widow of William J. Hollis, has four children, all of whom have attended Winnona Park School, where she was a member of the PTA for eighteen years. Long active in various civic organizations, Mrs. Hollis is a member of the Democratic Women of DeKalb County, Decatur Mimosa Garden Club, DeKalb Council for the Arts, Baron DeKalb Chapter of the D. A. R., DeKalb Historical Society and of the Decatur First United Methodist Church. Mrs. Hollis also recently earned a Law degree from Woodrow Wilson Law School.

The main thrust of Mrs. Hollis' campaign is to be available to the citizens of Decatur and responsive to their wants and needs when she serves as City Commissioner.

The incumbent has been a resident of Decatur for 25 years and presently lives on Pinecrest Avenue. Employed by The Trust Company of Georgia, Mr. Johnson did his undergraduate work at Georgia Tech and received his MBA from Georgia State University in 1973.

Mr. Johnson has served as Chairman of the Decatur Bicentennial Commission and of the Sesquicentennial Celebration Committee. He is a member of the Steering Committee of Goals for Decatur, DeKalb Chamber of Commerce Committee of 100, a Director on the Samuel L. Jones Boys Club Board and s Section Chairman for United Way.

Candidate Forum

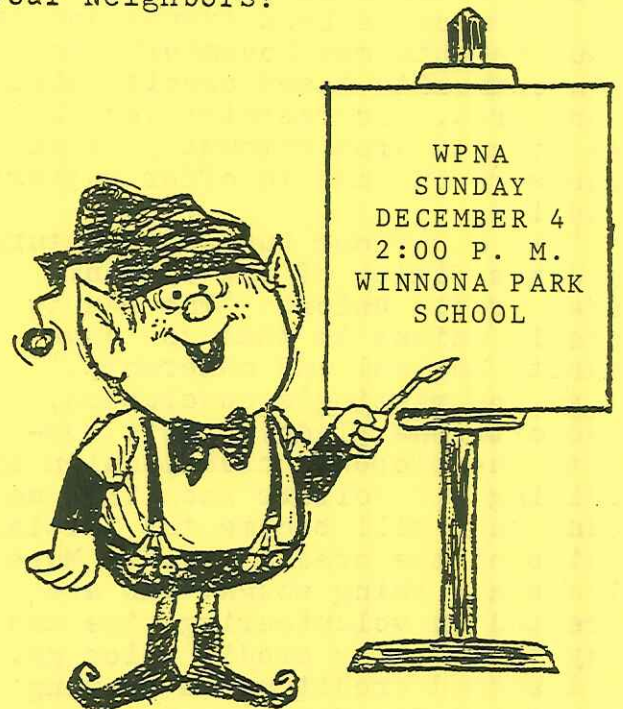

Credit Union

Decatur residents who live
south of Ponce de Leon Avenue and in
Decatur heights met November 8 to
form a community based credit union
for the area. Representatives from
three Atlanta area community credit
unions were on hand to offer support
and advice.

"Its a serious business venture"
said James Finley of the Lithonia
Federal Credit Union. "The beauty
of credit unions is that you have
community control and ownership."

At the meeting's conclusion,
twelve citizens pledged their sup-
port to the proposed credit union by
depositing six dollars each into an
account that will become the initial
deposits of the credit union. More
citizens are being sought who are
interested in volunteering time and
energy to make the credit union go.

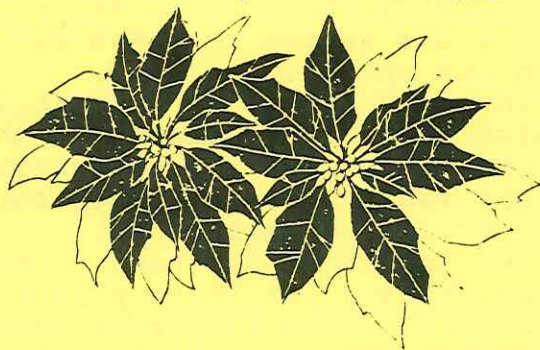
