#### SHEARER TO SPEAK

Economist and political activist Derek Shearer will speak at Agnes Scott College on Wed., May 19th at 8:30 p.m. in Presser Hall. In his talk on "Who will Control the Economy in the 1980's: Popular Power vs. Corporate Control", he will discuss many of the progressive policies proposed in his book, Economic Democracy.

Mr. Shearer should be particularly interesting to neighborhood-oriented folks. He is Director of Urban Studies at Occidental College and a member of the Planning Commission of Santa Monica, Calif. He & his wife, who is mayor of Santa Monica, were recently featured on a segment of TV's 'Sixty Minutes'. Progressives won a majority of that city's commission and have enacted tough legislation, such as strict zoning and rent controls, that have antagonized the city's pro-development interests.

Shearer will speak on "The Santa Monica Model: Progressive Alternatives to the New Federalism" at the City Planning Department of Ga. Tech on May 20th at 2 p.m.

#### D.O.T. TO RELEASE SYCAMORE HOUSES?

During the Marta rail construction, many Decatur houses were destroyed; however thanks to a neighborhood group called 'Save Old Sycamore', two of the more prominant houses were saved by moving them out of the construction area and down further on Sycamore to other Marta property. There, unoccupied and unattached (to plumbing, etc) they have sat for years (see map this page).

It has been determined that Marta doesn't need the houses or the property on which they are located but sale is being held up at the request of the Department of Transportation (D.O.T.). D.O.T. wants the property held in case they are successful in getting the Howard Street Connector built. This is a proposed highway that would run through Decatur along Howard Ave. and over to E. Ponce de Leon at the E. Ponce and Sycamore Drive intersection (see map). The argument for holding the houses is financial -- D.O.T. doesn't want them fixed up because if they had to repurchase them, the state would have to pay a higher price. So there the houses sit.

Decatur has long opposed the building of any such thoroughfare and has pressured D.O.T. and Marta to go ahead and release the houses for sale. A compromise seems to be possible whereby Decatur would get the houses put on the market and D.O.T. could retain enough land necessary to build a thoroughfare. This of course, would leave the question of the highway open for debate at some future time. If both sides agreed to this, the houses would be sold be a bidding process (see 'Marta Property Sale' this page), to the highest bidder.

It is an interesting point that, when the houses are sold, the federal government will get 80% of the money since they put up 80% of the purchase funds.


#### MARTA PROPERTY SALE

When the Marta rail line was built, there was a great deal of property condemned along the construction route. Some excess property, not needed by Marta, will be sold shortly. The 21 parcels will include the old Carpenter house and lot at 615 Sycamore St. and a house and lot at 124 Sycamore Drive (corner of Sycamore Dr and E. Ponce). See map this page.

The property will be sold by sealed bid to the highest bidder, all sales cash (this means Marta doesn't finance them although you could get financing elsewhere). To bid, you must obtain a bid 'package' containing the necessary forms and information from Marta. 

There were two initial meetings with Officer Rollins of the Decatur Police (one with Mimosa residents & one sponsored by WPNA for the whole neighborhood), but there has been little or no follow-up that we have been able to uncover. Last month WPNA asked for volunteers from each street in an effort to go ahead with the organization of the Neighborhood Watch for Winnona Park. We received two responses (one from Mimosa Dr and one from Inman).

#### response to anti - highway petition

In March, WPNA submitted to the Decatur City Commission a petition urging the commissioners to continue opposition to any major thoroughfare through Decatur. This information was passed on to various of our public officials, three of whom honored us with a reply. Here's their reactions: Rep. Eleanor Richardson wrote, certainly shall continue to oppose the construction of the Decatur Parkway". Senator Lawrence (Bud) Stumbaugh said he shared our concern about keeping our neighborhood together and wrote, "I hope I can be helpful in your attempts to deter the building of the Decatur Parkway". And from Senator Pierre Howard: "Please know that my opposition to the thoroughfare very much remains".


